FACTS & QUESTIONS

WHAT DOES A FOOD & BEVERAGE MINIMUM CONSIST OF?

A food and beverage minimum is the minimum amount that must be spent in order to secure your event space. The food and beverage minimum is required regardless of the number of guests that attend. Food and beverage minimums vary based on the location, day of week, time of year, group size, and space requested. If this minimum amount is not met, the remainder will be charged as a space fee. Please keep in mind, the food & beverage minimum does not include sales tax, and gratuity.

HOW DO I CONFIRM MY EVENT RESERVATION?

Your event will be confirmed upon the Events Manager receiving a signed Catering Agreement and Credit Card Authorization form. After the Events Manager sends the Catering Agreement and Credit Card Authorization form, we ask that you please sign and return within three business days.

WHEN DO I SUBMIT MY MENU SELECTIONS AND GUEST COUNT?

All food and beverage selections must be submitted to the Events Manager two weeks prior to your event. This will help ensure product is ordered and delivered on time. A final guest count will be due no later than three calendar days before the event. If this information is not provided by this time, the original guest count will be charged. If the guest count increases on the day of the event, we will do our best to accommodate. However, we cannot guarantee that additional food and space will be provided.

WHAT HAPPENS IF I CANCEL MY EVENT?

GROUP DINING

We understand that life doesn't always go as planned and that you may need to cancel your event. A cancellation can be made up to 72 hours prior to the event without a penalty. If a cancellation is made within 72 hours of the event, you will be responsible for 50% of the food and beverage charge, and the 4% service charge on the full minimum. If a cancellation is made within 24 hours of the event, you will be responsible for 100% of the food and beverage charge and 18% gratuity.

WHAT HAPPENS TO MY CREDIT CARD INFORMATION?

In order to secure the reservation, we do require a credit card on file, however the credit card on file will not be charged until the conclusion of the event. The required credit card authorization provides consent for us to charge the credit card on file should payment not be presented on the day of the event.

PATIO EVENTS

We always hope the weather cooperates; however, all patio booked events are rain or shine. In the case of inclement weather, the management team will do their best to relocate the event based on the other reservations and contracts previously made. There is no guarantee that relocation will be possible, and you will not receive a credit, nor will your food and beverage minimum be reduced or waived.

PAYMENT

Unless otherwise specified on your Catering Agreement, upon completion of the event, one check will be prepared with food, beverages, any unmet Food and Beverage Minimum, tax and gratuity. Acceptable forms of payment are cash and all major credit cards.

A separate check option will not be offered for large party events, unless the Food and Beverage Minimum is met, and arrangements are made with the Events Manager and restaurant management team prior to the event. We cannot guarantee that a separate check option will be available, it is on a case by case basis, and is determined based on the guest count, time frame, and other variables.
